# Results of Exercise of Proxy Voting Rights at general meetings from October to December 2020

To appropriately deal with conflicts of interest and further enhance the visibility of its exercise of voting rights, Sumitomo Mitsui DS Asset Management (SMDAM) will individually disclose voting results of all proposals for which it exercises voting rights it holds in investee companies and investment corporations.

From the perspective of responding to concerns about conflicts of interests,

- (i) in its exercise of voting rights on all proposals of its major shareholders Sumitomo Mitsui Financial Group, Daiwa Securities Group, and MS&AD Insurance Group Holdings, SMDAM will vote in favor of resolutions only when agreement to these concurs with recommendations of external advisory bodies and SMDAM standards for determining the exercise of voting rights; and
- (ii) as a general rule, SMDAM will vote in favor of resolutions only when agreement to these concurs with recommendations of external advisory bodies and SMDAM standards for determining the exercise of voting rights in case that employees/officers of SMDAM or officers or employees holding important positions of major shareholders of SMDAM are included in proposals for the appointment of directors and auditors.

The number of resolutions for which voting rights were exercised at shareholder general meetings held from October to December 2020 was 1,188 company-proposed resolutions and 5 shareholder-proposed resolutions. In the breakdown of company-proposed resolutions according to proposal content, "Appointment or dismissal of directors" was the most common with 885 resolutions, followed by "Appointment or dismissal of auditors" with 101 resolutions, "Appropriation of retained earnings" with 82 resolutions, "Partial amendment of the articles of incorporation" with 40 resolutions, and "Executive compensation" with 39 resolutions.

The exercise of voting rights in accordance with "Criteria for Determining the Exercise of Voting Rights" and "Current Policy for Exercising Voting Rights in Japan Based on the Impact of the New Coronavirus", resulted in a 23.5% objection rate regarding company-proposed resolutions. The breakdown of this objection rate according to resolution content was 23.1% for "Appointment or dismissal of directors," 36.6% for "Appointment or dismissal of auditors," 2.4% for "Appropriation of retained earnings," 5.0% for "Partial amendment of the articles of incorporation," and 38.5% for "Executive compensation."

The number of resolutions for which voting rights were exercised at general investors' meetings held from October to December 2020 was 51 corporation-proposed resolutions and 0 unitholder-proposed resolutions. In the breakdown of corporation-proposed resolutions according to resolution content, "Appointment or dismissal of supervisory officers" was the most common with 20 resolutions, followed by "Appointment or dismissal of executive officers" with 16 resolutions, and "Changes to the articles of incorporation" with 12 resolutions.

The exercise of voting rights in accordance with "Criteria for Determining the Exercise of Voting Rights" resulted in a 31.4% objection rate regarding corporation-proposed resolutions. The breakdown of this objection rate according to resolution content was 15.0% for "Appointment or dismissal of supervisory officers," 78.8% for "Appointment or dismissal of executive officers," and 16.7% for "Changes to the articles of incorporation."

SMDAM has disclosed the main reasons for its objection to resolutions concerning both domestic stocks and J-REITs for each investee and resolution, and stated representative reasons in cases where there were multiple reasons for objecting. The "approval/objection" disclosed for each investee and resolution is an indication of how voting rights were exercised based on SMDAM "Criteria for Determining the Exercise of Voting Rights".

The <u>"Criteria for Determining the Exercise of Voting Rights"</u>, which SMDAM formulates and discloses to eliminate arbitrariness as much as possible, establish standards aimed at achieving appropriate corporate governance with the objective of increasing corporate value. SMDAM will

continually revise and improve these standards as necessary based on changes in the external environment and results of engagement with investee companies, etc., and will make an even stronger commitment to increasing corporate value through the exercise of voting rights and active dialogue with investee companies.
