

Results of Exercise of Proxy Voting Rights at general meetings from July to September 2018

Sumitomo Mitsui Asset Management (SMAM) discloses individually the results of the exercise of voting rights for all proposed resolutions of companies that it owns with the aims of appropriately handling conflicts of interest and further increasing transparency of the exercise of voting rights.

The number of proposed resolutions made at shareholder general meetings held from July to September 2018 was 702 management-proposed resolutions and 0 shareholder-proposed resolutions. When the management-proposed resolutions are broken-down by content, "Appointment and dismissal of directors" was the most common with 518 resolutions, next was "Appointment and dismissal of auditors" with 70 resolutions, then "Appropriation of retained earnings" with 49 resolutions, "Partial amendment of the articles of incorporation" with 26 resolutions, and "Executive compensation" with 23 resolutions.

The proportion of opposition to management-proposed resolutions as a result of the exercise of voting rights in accordance with guidelines for determining exercising of voting rights ([SMAM Guidelines](#) on the Exercise of Proxy Voting Rights) was 31.3% (the proportion of opposition to individually examined resolutions at general meetings of shareholders in July to September 2017

was 37.6%). The proportion of opposition by resolution content was 34.2% for “Appointment and dismissal of directors” (43.6% in 2017), 28.6% for “Appointment and dismissal of auditors” (24.0% in 2017), 20.4% for “Appropriation of retained earnings” (20.0% in 2017), 0.0% for “Partial amendment of the articles of incorporation” (0.0% in 2017), and 34.8% for “Executive compensation” (33.3% in 2017).

The proportion of opposition to resolutions for “Appointment and dismissal of directors” decreased year-on-year due to an increase in the number of director candidates meeting ROE standards. Meanwhile, the proportion of opposition to resolutions for “Appointment and dismissal of auditors” increased due to a higher number of outside auditor candidates failing to meet the independence criteria in the [SMAM Guidelines](#).

Regarding J-REITs, resolutions have been tabulated since April 2018, when individual reviews began.

In general meetings from July to September 2018, 27 resolutions were management proposals and 0 resolutions were unitholder proposals. By content of the resolutions, "Appointment and dismissal of executive officers" was the most frequent subject with 12 resolutions, followed by 10 resolutions concerning "Appointment and dismissal of supervisory officers," and 5 resolutions concerning "Changes to the articles of incorporation."

The rate of opposition to management proposal resolutions was 37.0%. The rate of opposition by content in order of the number of resolutions was 66.7% for "Appointment and dismissal of executive officers," and 20.0% for "Appointment and dismissal of supervisory officers."

SMAM discloses the main reasons for the "against" votes cast for both Japanese equities and J-REITs for each investment and resolution. In the event that there was more than one reason for opposition, a typical reason is listed.

In the published [SMAM Guidelines](#), which have been formulated in order to minimize arbitrariness in exercising voting rights as much as possible, standards have been established for the purpose of corporate value with aims such as bringing about appropriate corporate governance. In addition to amending and improving the [SMAM Guidelines](#) based on changes in the external environment and the results of engagement with investee companies, SMAM is strongly committed to improving corporate value through exercising voting rights and active dialog with investee companies.
