The number of proposed resolutions made at shareholder general meetings held from October to December 2017 was 830 company-proposed resolutions and 7 shareholder-proposed resolutions. When the company-proposed resolutions are broken-down by content, "Appointment of directors" was the most common with 612 resolutions, next was "Appropriation of retained earnings" with 64 resolutions, then "Appointment of auditors" with 57 resolutions, followed by "Partial amendment of

the Articles of Incorporation" with 34 resolutions and "Amendment of director compensation" with 29 resolutions.

The proportion of opposition to company-proposed resolutions as a result of the exercise of voting rights in accordance with guidelines for determining exercising of voting rights (SMAM Guidelines on the Exercise of Proxy Voting Rights) was 29.2% (the proportion of opposition to individually examined resolutions at general meetings of shareholders in October to December 2016 was 40.1%). The proportion of opposition by resolution content was 33.0% for "Appointment of directors" (44.9% in 2016), 14.1% for "Appropriation of retained earnings" (25.0% in 2016), 33.3% for "Appointment of auditors" (30.0% in 2016), 2.9% for "Partial amendment of the Articles of Incorporation" (0% in 2016), and 20.7% for "Amendment of director compensation" (33.3% in 2016).

For "Appointment of directors," the proportion of opposition decreased compared to the same period in the previous year due to an increase in the candidates for director who did not conflict with ROE or performance criteria, and for "Appropriation of retained earnings," the opposition proportion also decreased due to an increase in resolutions that met SMAM Guidelines on dividend criteria.

The main reasons for opposition were disclosed for each company and proposed resolution, and in cases where there were multiple reasons for opposition, representative reasons were given. (The main reasons for the exercise of votes in favor of shareholder proposals were also disclosed)

The <u>SMAM Guidelines</u> which establish and publish measures for eliminating arbitrariness in the exercising of voting rights set high standards with the aim of increasing corporate value by implementing appropriate corporate governance and raising the baseline ROE levels, among other initiatives. SMAM is focused on modifying and revising the <u>SMAM Guidelines</u> as necessary based on changes in the external environment, the results of engagement with investee companies, etc. and is strongly committed to increasing corporate value through exercising voting rights and active dialog with investee companies.
