The number of proposed resolutions made at shareholder general meetings held from January to March 2018 was 2,385 company-proposed resolutions and 15 shareholder-proposed resolutions. When the company-proposed resolutions are broken-down by content, "Appointment of directors" was the most common with 1,784 resolutions, next was "Appointment of auditors" with 212 resolutions, then "Appropriation of retained earnings" with 182 resolutions, followed by "Amendment of director compensation" with 87 resolutions and "Partial amendment of the Articles of Incorporation" with 52 resolutions.

The proportion of opposition to company-proposed resolutions as a result of the exercise of voting rights in accordance with guidelines for determining exercising of voting rights (SMAM Guidelines on the Exercise of Proxy Voting Rights) was 29.2% (the proportion of opposition to individually examined resolutions at general meetings of shareholders in January to March 2017 was 34.1%). The proportion of opposition by resolution content was 32.9% for "Appointment of directors" (36.8% in 2017), 25.9% for "Appointment of auditors" (28.9% in 2017), 9.9% for "Appropriation of retained earnings" (8.7% in 2017), 11.5% for "Amendment of director compensation" (25.0% in 2017), and 1.9% for "Partial amendment of the Articles of Incorporation" (3.7% in 2017).

For "Appointment of directors" the proportion of opposition decreased compared to the same period in the previous year due to an increase in the candidates for director who did not conflict with ROE criteria, and for "Amendment of director compensation" the opposition proportion also decreased due to an increase in resolutions that met SMAM Guidelines on performance criteria. The main reasons for opposition were disclosed for each company and proposed resolution, and in cases where there were multiple reasons for opposition, representative reasons were given.

The <u>SMAM Guidelines</u> which establish and publish measures for eliminating arbitrariness in the exercising of voting rights set high standards with the aim of increasing corporate value by implementing appropriate corporate governance and raising the baseline ROE levels, among other initiatives. SMAM is focused on modifying and revising the <u>SMAM Guidelines</u> as necessary based on changes in the external environment, the results of engagement with investee companies, etc. and is strongly committed to increasing corporate value through exercising voting rights and active dialog with investee companies.
