### 4. Organization (Effective as of April 1, 2020)

We have successfully achieved integration tasks since the merger in April 2019. As the best asset management firm for better Quality of Life, we decide to make organizational change as of April 2020 so that we will further promote our efforts to deliver more satisfactory services to our clients going forward. Please see details as below and "Organizational Chart on Appendix 3."

- (1) Enhancement of Investment Management Capability
  - i) Given increasing demand for alternative investment solutions under prolonged low interest rate economy, since this April CEO will have direct control over Alternative Investment Dept. which is currently under control of Head of Investment Management Division. Likewise, CEO will also directly control Global Investment Management Department which is currently under control of Head of Product Division.
  - ii) We will set up Advanced Technology Investment Development Section within Investment Development Dept. to enable us to enhance our investment management capability and accelerate development of new investment products by leveraging cutting-edge information technologies.
  - iii) We will Integrate Corporate Research Dept. I and II into Corporate Research Dept. This integration enables us to enhance our research capabilities with broader and intense coverage of Japanese equities.
- (2) Enhancement of Marketing Capability
  - i) We will integrate Retail Marketing Division and Institutional Marketing Division into Marketing Division. With this integration aiming to faster decision making, more flexible resource management and development of marketing staff with seasoned knowledge of broader client needs, we will continue to deliver the highest quality investment solutions to our clients.
  - ii) We will integrate Investment Trust Marketing Dept. I, II and III into Investment Trust Marketing Dept. Likewise, we will integrate Institutional Marketing Dept. I and II into Institutional Marketing Dept. With such an integration of marketing functions, we enable us to share client-related information more effectively across organization and respond to rapidly changing client needs and market environment accordingly.

- iii) In accordance with integration of Retail Marketing Division and Institutional Marketing Division, we will also reorganize client support functions in charge of various marketing materials and investment management reports into Client Service Dept.\* and Client Reporting Dept.\*\*
  - \* Sales Support Dept. and Institutional Business Promotion Dept. will be integrated into Client Service Dept. to streamline functions of developing marketing materials of investment products as well as functions of various client-related administrative works.
  - \*\* Investment Reporting Dept. and Institutional Business Administration Dept. will be integrated into Client Reporting Dept. to streamline functions of developing investment management reports.
- (3) Expansion of Overseas Business

As global business environment is rapidly changing, we are invited to determine our global strategy in a timely manner and also to tighten relationship with our overseas business partners. To this end, we will integrate International Business Planning Dept., International Business Development Section and International Marketing Dept. into International Business Dept. In addition, CEO will have direct control over the integrated department.

(4)Reorganization of corporate functions

We will abolish Corporate Planning and Administration Division to conduct their operations in more efficient manner. We also integrate Communication Dept. into Corporate Planning Dept. to closely coordinate internal communication with corporate strategy. Meanwhile, operational risk management function within IT & Operation Dept. will be integrated into Risk Management Department.


